**TENDER FOR PROVIDING VEHICLE PARKING SERVICES AT  
SJNAHS CAMPUS**

**TERMS AND CONDITIONS**

1. The selected bidder will run the parking services for Bicycles Two wheelers / Three wheelers and Four wheelers on round the clock (24 hours) basis at the **St. John's National Academy of Health Sciences campus** for a period of **ONE YEAR** for the general public i.e., patients, their relatives, attendants and visitors to the hospital.
2. The tenderer shall quote his/her offer for one year license.
3. The parking fee once paid by the owner of the vehicle would be valid for 12 hours per single entry only.
4. The Licensee shall maintain the area and facilities in good and clean condition.
5. The public parking services will not include the staff parking areas reserved for the staff. In the event of any staff parking the vehicle at the stand in an emergency, no parking fee shall be collected from the concerned staff.

6. The charges for parking are:
  - 2 - Wheelers Rs.3/-
  - 3 - Wheelers Rs.4/-
  - 4 - Wheelers Rs.6/- &
  - Bicycles Re.1/-
7. The parking services shall function on all days and round the clock (24 hours basis).
8. The Licensee shall not employ children for operating the parking services and shall abide by all applicable laws including the Karnataka Shops and Commercial Establishment Act.
9. The Licensee should obtain permission from the competent statutory authority, if required, and comply with all the requirements of law in force at the given time and also taxes if any, including service tax.
10. Licensee shall provide sufficient number of staff and should provide efficient service with courtesy and dedication.
11. Licensee shall be responsible for any loss or damage to the vehicles or any part of the vehicle, while the vehicle is parked in the designated parking area.
12. An additional deposit of Rs.50,000/- will be collected towards maintaining cleanliness of the demarcated areas. In the event of non-compliance, a casual worker will be employed by the

licensor and his wages will be deducted from the additional deposit.

13. The workers shall wear identification cards provided by the Hospital authorities and uniforms provided by the licensee.
14. A fabricated movable shelter for the workers shall be provided by the licensee at his own cost and it shall be installed at the place provided by the licensor.

Tender forms can be obtained from the CBCI Accounts Department, Directorate, St. John's National Academy of Health Sciences on payment of Rs.1000/- (non refundable) towards the cost of Tender form. Tender forms will be issued from 2<sup>nd</sup> July 2010 to 12<sup>th</sup> July 2010 on all working days between 9.00 am to 4.00 pm.
2. Tender should be accompanied with a crossed Demand Draft or bankers cheque for Rs.25,000/- (refundable) drawn in favour of CBCI Society for Medical Education payable at Bangalore.
