3. Study certificate issued by recognized Schools in India stating that the candidate has studied for **7 continuous years including Standard X and XII**
4. Baptism Certificate attested by the Bishop of the applicant
5. Certificate in prescribed format from the Bishop of the applicant stating that the applicant is a Roman Catholic Christian belonging to a Tribal Community in his Diocese (**see Certificate Template 3 in Section 2.1.7**).

4. Baptism Certificate attested by the Bishop of the applicant
5. Certificate in prescribed format from the Bishop of the applicant stating that the applicant is a member of the Roman Catholic Christian community of ScheduledCaste origin belonging to his Diocese (**see Certificate Template 4 in Section 2.1.7**).
