INFORMATION AND INSTRUCTIONS FOR ADMISSION PROCESS

1. MPT ADMISSION:

Admission of the Provisionally Selected candidate to the MPT Course will be held on 15th October 2024.

Reporting Time: 9.00 am

Venue: Admissions' Office, Ground floor, St. John's Medical College

Selected candidates who do not report for admission on the above date will have forfeited their seats.

i. Admission protocol:

Step 1: Selected candidates shall report to the **ADMISSIONS' OFFICE**, Ground Floor, St. John's Medical College at 9.00 am, give an acceptance letter, and obtain the **ADMIT SLIP**.

Step 2: Proceed to the **ACADEMIC SECTION** and submit the Admit Slip.

- #### **ii. Candidates shall ensure that all the original documents and one set of photo copies are handed over to the Academic Section and 5 passport size photographs.**
- 10th Standard marks card
 - 12th Standard marks card
 - Qualifying Degree (all years) marks card, Internship Completion Certificate and Qualifying degree certificate
 - For Catholic candidates only: Baptism certificate and/or a letter from Parish priest stating that the candidate is a *bona fide* member of the parish
 - SC/ST/OBC certificate for applicable candidates
 - Transfer Certificate
 - Migration Certificate
 - Eligibility Certificate (Refer below for details)

iii. Eligibility Certificate (to be procured before the Admission Process)

Selected Candidates with Bachelors' degree from Universities other than **Rajiv Gandhi University of Health Sciences (RGUHS)**, Karnataka, need to apply for the **Eligibility Certificate** and submit the same to the Academic Section. Failure to produce the Eligibility Certificate and original documents as required by the Academic Section within the stipulated time and without the written permission of the Director will be considered **NON-ACCEPTANCE** of selection.

- #### **iv. After the completion of the Academic Section procedures, the candidates shall proceed to the fee payment counter at the Accounts Section for the payment of fees.**
- #### **v. The candidate shall pay the fees by 4.00 pm on the day of admission. Any candidate failing to pay the fees by 4.00 pm on 15th October 2024 will forfeit the seat.**
- #### **vi. The candidates are then required to meet the Executives in their respective offices for their approval.**
- #### **vii. The admission granted is considered "PROVISIONAL" until all the original supporting documents submitted are approved by the RGUHS, Karnataka.**



2. HOSTEL ACCOMMODATION: (Subject to availability)

Candidates requiring hostel accommodation on Campus should apply to the Associate Director, St. John's Medical College, during the office hours on **the day of the admission.**

Candidates who have obtained hostel accommodation are required to occupy their hostel rooms latest by 4:00 PM on the day prior to course commencement.
